**ORDER GRANTING DIRECT PURCHASER PLAINTIFFS' UNOPPOSED
MOTIONS FOR PRELIMINARY APPROVAL OF SETTLEMENTS WITH
DEFENDANTS BUTTERBALL, LLC (ECF NO. 1955), AND HORMEL FOODS
CORPORATION AND JENNIE-O TURKEY STORE, INC. (ECF NO. 1936),
APPROVAL OF THE MANNER AND FORM OF CLASS NOTICE PLAN, AND
RELATED RELIEF**

Direct Purchaser Plaintiffs ("DPPs") have entered into a settlement agreement with Defendant Butterball, LLC ("Butterball") on behalf of the direct purchaser litigation class certified by the Court (the "Butterball Settlement"). DPPs have also entered into a settlement agreement with Defendants Hormel Foods Corporation and Jennie-O Turkey Store, Inc. on behalf of the direct purchaser litigation class certified by the Court (the "JOTS Settlement"). Before the Court are (1) DPPs' Unopposed Motion for Preliminary Approval of Settlement with Defendant Butterball, Approval of the Manner and Form of Class Notice Plan, and Related Relief ("Butterball Motion"), and (2) DPPs' Unopposed Motion for Preliminary Approval of Settlement with Defendants Hormel Foods Corporation and Jennie-O Turkey Store, Inc. ("JOTS Motion"). These Motions seek an order granting preliminary approval to the Butterball Settlement and the JOTS Settlement, approving the manner and form of the proposed Class Notice Plan, including for the previously approved DPP settlements with Defendants Agri Stats, Inc., House of Raeford Farms, Inc. ("House of Raeford"), Prestage Farms, Inc., Prestage Foods, Inc., and Prestage Farms of South Carolina, LLC ("Prestage"), Foster Farms LLC and Foster Poultry Farms LLC, ("Foster Farms"), and Perdue

Farms, Inc. and Perdue Foods LLC (“Perdue”) (collectively, with the Butterball Settlement and JOTS Settlement, the “Settlements” or “Settlement Agreements”), that will inform the Certified Class of the Court’s order approving the Settlements. The Court, having reviewed the Motions; their accompanying memorandum, declarations and exhibits thereto; the proposed Settlement Agreements; and the file; hereby **ORDERS AND ADJUDGES:**

The Court’s Previous Class Certification Order

1. The Court certified the following DPP litigation class in its order dated January 22, 2025 (ECF No. 1107) (the “Certified Class”):

All persons and entities who directly purchased fresh or frozen, uncooked turkey breast, ground turkey, or whole bird turkey products (the “Class Products”) from Defendants in the United States during the Class Period.

2. Excluded from the Class are all persons who previously filed a valid request for exclusion from the Certified Class by the Court-ordered deadline (ECF No. 1296). Also specifically excluded from the Certified Class or DPP Class are the Defendants and their alleged Co-Conspirators; the officers, directors or employees of any Defendant or alleged Co-Conspirator; any entity in which any Defendant or their alleged Co-Conspirator has a controlling interest; any entity with an interest, controlling or non-controlling, in a Defendant or their co-conspirator; any entity where an individual owner, trust, and/or holding company also had an interest in any Defendant (whether as an individual, member, trust, trustee, legal representative, heir or assign) of greater than 5% during any year of the Class Period; any (in whole or in part) affiliate, legal representative, heir or assign of any Defendant or their alleged Co-Conspirator. Also excluded from this Class are any federal, state or local governmental entities, any judicial officer presiding over this action and the members of his/her immediate family and judicial staff, any juror assigned to this action, and any alleged Co-Conspirator identified in this action.

3. The Class Products have the following exclusions:

- a. Turkey breast products exclude: (1) turkey breasts used to make ground turkey; (2) turkey breast tenderloins; (3) organic turkey breast products; (4) NAE or ABF turkey breast products; and (5) cooked or RTE turkey breast products.
 - b. Ground turkey products exclude: (1) ground turkey products made from turkey breasts; (2) ground turkey products made from turkey wings; (3) burgers, sausages, and patties; (4) organic ground turkey products; (5) NAE or ABF ground turkey products; and (6) cooked or RTE ground turkey products.
 - c. Whole bird turkey products exclude: (1) organic turkey whole bird products; (2) NAE or ABF turkey whole bird products; and (3) cooked or RTE turkey whole bird products.
4. The Class Period is January 1, 2010, through December 31, 2016.
 5. The Court previously appointed the law firms Hagens Berman Sobol Shapiro LLP and Lockridge Grindal Nauen PLLP as Co-Lead Class Counsel for the Certified Class.
 6. The Court previously appointed John Gross and Company, Inc. and Maplevale Farms, Inc. as class representatives for the Certified Class.
 7. The Court directs notice regarding certification of the direct purchaser litigation class be distributed to the Certified Class pursuant to Federal Rule of Civil Procedure (“Rule”) 23(c)(2)(B).

Preliminary Approval of the Butterball Settlement

8. DPPs have entered into the Settlement Agreement with Butterball on behalf of the Certified Class.
9. The Court has jurisdiction over this action and each of the Parties to the Settlement Agreement. Upon review of the record, the Court finds that the Settlement Agreement, which was

arrived at by arm's-length negotiations by highly experienced counsel, meets all factors under Rule 23(e)(2) and will likely be granted Final Approval by the Court, subject to further consideration at the Court's Fairness Hearing. The Court preliminarily determines that the Settlement is fair, reasonable, adequate, and in the best interests of the Certified Class; raises no obvious reasons to doubt its fairness; and raises a reasonable basis for presuming that the Settlement satisfies the requirements of Rule 23(c)(2), Rule 23(e), and due process.

10. The Court grants preliminary approval to the Settlement.

Preliminary Approval of the JOTS Settlement

11. DPPs have entered into the Settlement Agreement with JOTS on behalf of the Certified Class. *See* JOTS Motion (ECF No. 1936).

12. The Court has jurisdiction over this action and each of the Parties to the Settlement Agreement. Upon review of the record, the Court finds that the Settlement Agreement, which was arrived at by arm's-length negotiations by highly experienced counsel, meets all factors under Rule 23(e)(2) and will likely be granted Final Approval by the Court, subject to further consideration at the Court's Fairness Hearing. The Court preliminarily determines that the Settlement is fair, reasonable, adequate, and in the best interests of the Certified Class; raises no obvious reasons to doubt its fairness; and raises a reasonable basis for presuming that the Settlement satisfies the requirements of Rule 23(c)(2), Rule 23(e), and due process.

13. The Court grants preliminary approval to the Settlement.

No New Opportunity to Opt-Out of Certified Class

14. Given that Certified Class members have already been provided an opportunity to exclude themselves, the Court finds that an additional opportunity to opt out is not warranted and is not required here. The Court previously certified the DPP Class on January 22, 2025 (ECF No.

1107) and the deadline for class members to request exclusion ran well over one year ago (ECF Nos. 1230, ¶ 22; 1355, ¶ 18.) At this stage, fairness no longer requires giving Class members another opportunity to opt out. Indeed, “a second opt-out opportunity might inject additional uncertainty into settlement and create opportunities unrelated to the purpose of the second opt-out, potentially defeating some settlements and making others more costly.” *See* Manual for Complex Litigation (4th) § 22.611 at 313. The circumstances and facts favoring approval without an additional opt-out period are even stronger with the previously approved Foster Farms and Perdue settlements (ECF No. 1902.). To allow Class members to opt out after summary judgment has been granted in favor of Foster Farms and Perdue, the Court would invite Class members to make their opt-out decisions based on after-the-fact assessments of rulings and developments in the case and in a manner that permits them to avoid judgment. Such a result is contrary to the principles of Rule 23. *See In re Broiler Antitrust Litigation*, Case No.: 1:16-cv-08637, ECF. No. 7179, ¶ 8 (order granting preliminary approval of settlements and notice plan and stating that “[a]s Certified Class members have already been provided an opportunity to exclude themselves, the Court finds that an additional opportunity to opt out is not warranted and is not required here.”).

15. After issuing its January 22, 2025 Class Certification Order (ECF No. 1107), the Court issued an April 9, 2025, order directing notice of its Class Certification Order be distributed to the Certified Class. *See* ECF 1230, ¶ 11; *see also* ECF 1230-1, page 7 of 11 (Long Form Notice stating: “If you exclude yourself from the Certified Class, you will be excluded from the Settlements and from any future settlement or judgment obtained by the Direct Purchaser Plaintiffs against the non-settling Defendants in this case. Please also see the answer to Question No. 21 below.”). In the notice approved by the Court, class members were advised that any requests to be excluded from the Certified Class were due no later than May 22, 2025. ECF No. 1230-1. The

Court subsequently ordered that valid exclusions from the Certified Class were contained in Exhibit A (ECF 1355-1) and Exhibit B (ECF 1355-2) to the Court's July 29, 2025 order. *See* ECF 1355, ¶ 18 ("Persons or entities who timely and validly requested to be excluded from the Certified Class are listed in Exhibit A attached hereto."); *id.*, ¶ 19 ("A list of person or entities requesting to be excluded from the Certified Class who have partial assignments ("Partial Assignees") is set forth in the attached Exhibit B.). A copy of **Exhibit A** (ECF 1355-1) and **Exhibit B** (ECF 1355-2) are re-attached hereto for the avoidance of doubt.

Approval of the Manner and Form of Class Notice

16. The Court hereby directs that notice be distributed to the Certified Class members pursuant to Rule 23(c)(2)(B) and Rule 23(e)(1). Notice to the Certified Class shall be the responsibility of Co-Lead Class Counsel.

17. The Court hereby appoints A.B. Data, Ltd. ("A.B. Data") to administer the Settlement and Class Notice according to the plan set out in the Butterball Motion with respect to both the Butterball Settlement and the JOTS Settlement. The Court previously appointed A.B. Data to administer DPPs' settlements with Tyson, Cargill, Farbest Foods, Cooper Farms, Agri Stats, House of Raeford, Prestage, Foster Farms, and Perdue.

18. The Court hereby appoints The Huntington National Bank as the escrow agent for both the Butterball Settlement and the JOTS Settlement. The Court previously appointed The Huntington National Bank as escrow agent for DPPs' settlements with Tyson, Cargill, Farbest Foods, Cooper Farms, House of Raeford, and Prestage.

19. The Class Notice Plan set forth in the Motion is substantially similar to the notice plan approved by this Court for the Tyson settlement, the Cargill settlement, the Farbest/Cooper settlements, and the House of Raeford/Prestage settlements. *See* ECF Nos. 406, 1355, 1362, 1902.

It complies with Rule 23(c)(2)(B), Rule 23(e)(1), and due process because it constitutes the best notice that is practicable under the circumstances, providing individual notice via mail and email to all Certified Class members who can be identified through reasonable effort. The direct mail and email notice will be supported by reasonable publication notice to reach members of the Certified Class who cannot be identified through reasonable effort.

20. Given that Certified Class members have already been provided an opportunity to exclude themselves, the Court finds that an additional opportunity to opt out is not warranted and is not required here.

21. The Court approves the method of Notice to be provided to the Certified Class as described in the Settlement Agreements and in the Notice Plan delineated in the Devery Declaration, including use of the Long Form Notice (Devery Decl., **Exhibit 1**),¹ Short Form Notice (Devery Decl., **Exhibit 2**), Sample Media Banner Advertisement (Devery Decl., **Exhibit 3**), (collectively, “Class Notice Documents”), Claim Form (Devery Decl., **Exhibit 4**), and Purchase Audit Request Form (Devery Decl., **Exhibit 5**). The Class Notice Documents comply with Rule 23(c)(2)(B), Rule 23(e)(1), and due process because they are reasonably calculated to adequately apprise Certified Class members of (i) the nature of the action; (ii) the definition of the class certified; (iii) the class claims, issues, or defenses; (iv) that a Certified Class member may enter an appearance through an attorney if the member so desires; (v) the time and manner for submitting objections; and (vi) the binding effect of a class judgment on Certified Class members under Rule 23(c)(3). Additionally, the notices adequately notify the class regarding a claims process for proceeds of settlements reached on behalf of the Certified Class and how to object to the

forthcoming motion for payment of attorneys' fees, litigation expenses, and service awards. The Claim Form adequately provides the class with instructions for submitting claims, and the Purchase Audit Request Form adequately provides the class with instructions for submitting requests to audit their purchase information contained on the Claim Form.

22. The Court reserves a decision on the award of any eventual *cy pres* funds that may be left at the conclusion of the distribution processes. However, to avoid the expense of further notice to the Certified Class of a *cy pres* recipient, the Court approves the Notice Plan providing the following four options as potential *cy pres* recipients that Co-Lead Counsel may suggest, subject to the Court's approval, if there are *cy pres* funds available at the conclusion of the claims process and it is not cost-effective to provide a further re-distribution to the Certified Class: (1) the American Antitrust Institute (AAI),² (2) No Kid Hungry,³ (3) distributed equally to the Attorneys General for the States of California, Minnesota, North Carolina, Tennessee, Texas, and Utah,⁴ or (4) escheat to the State of Illinois, the forum for this litigation for the past seven years.

23. Non-substantive changes, such as typographical errors, can be made to the Class

Notice Documents by agreement of the parties without leave from the Court. Further, Co-Lead Counsel may revise the not to exceed litigation expenses listed in the notices without further order of the Court prior to notice being commenced.

24. The Court permits Co-Lead Class Counsel to withdraw up to \$250,000 from each of the Butterball Settlement Fund and the JOTS Settlement Fund, in addition to the amounts permitted to be withdrawn from the House of Raeford and Prestage Settlements (*see* ECF No. 1902, ¶ 21), to pay the costs of notice and for Preliminary Approval, Final Approval, and administration of the claims process for the Settlement Agreements. Any costs of notice actually incurred by Co-Lead Class Counsel are non-refundable.

25. A.B. Data shall cause Class Notice to be mailed by first class mail, postage prepaid, to all members of the Certified Class whose names, mailing addresses, and email addresses can be derived from information provided by the Defendants in this action. The Long Form Notice shall be provided to all persons who request it in response to the Short Form Notice. A.B. Data is hereby directed to cause the Media Banner Advertisement to be published for four weeks in digital advertising campaigns on the websites for *Supermarket News* (www.supermarketnews.com) and *Nation's Restaurant News* (www.nrn.com). Comparable alternative websites relevant to the Certified Class may be used if any of these websites will not accept the Media Banner Advertisement or if advertising space or inventory are not available at the time the advertisements are placed.

Schedule for Class Notice and Fairness Hearing

26. The Court hereby sets the schedule below for the dissemination of Class Notice to the Certified Class; for Certified Class members to object to any or all of the Agri Stats, House of Raeford, Prestage, Foster Farms, Perdue, JOTS, or Butterball settlements; and for the Court's

Fairness Hearing, at which time the Court will determine whether the Settlements should be finally approved as fair, reasonable, and adequate. This Court may order the Fairness Hearing to be postponed, adjourned, or continued. If that occurs, the updated hearing date shall be posted on the case-specific website, but other than the website posting the parties will not be required to provide any additional notice to Certified Class members. The hearing may take place remotely, including via telephone or video conference.

November 10, 2026	Co-Lead Counsel shall file a motion for Final Approval of the Settlements and all supporting papers, and Co-Lead Class Counsel and Defendants Agri Stats, House of Raeford, Prestage, Foster Farms, Perdue, JOTS, and Butterball may respond to any objections to the proposed Settlements or Motion for Approval of Fees, Costs, and Service Awards

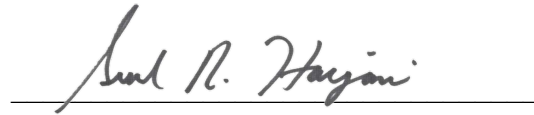

Other Provisions

27. If any of the Settlements are not granted Final Approval by this Court or are otherwise terminated by the Parties in accordance with the terms of their Settlement Agreements, the Court will modify any existing scheduling orders as necessary to ensure that the DPPs, Agri Stats, House of Raeford, Prestage, Foster Farms, Perdue, JOTS, or Butterball, as the case may be, will have sufficient time to prepare for the resumption of litigation.

⁷ Under CAFA, the Court may not issue an order giving final approval of a proposed settlement earlier than 90 days after the later of the dates on which the appropriate Federal official and the appropriate State official are served with notice of these proposed Settlements. *Id.* § 1715(d). Under the Settlement Agreement, within ten days of the filing of this motion, Butterball will serve upon the appropriate state officials and the appropriate federal official the CAFA notice required by Section 1715(b). Butterball confirmed on August 24, 2026 that its CAFA notice had been sent (ECF No. 1962) and JOTS confirmed on August 21, 2026 that its CAFA notice had been sent (ECF No. 1961).
